(POST MATRIC SCHOLARSHIP REGISTRATION RELEASE AND NETWORK AUTOMATION)

4-V : All the eligible **ST/SC/OBC/SEBC** students those who are prosecuting their study at Post-Matriculation or Post-Secondary stages are hereby informed that the online submission of duly filled-in PMS applications in **PRERANA Portal**, its scrutiny, and processing is scheduled to be held as per the date line indicated below.

Post Matric Scholarship Scheme:

Eligibility:

- ST/SC students who are continuing their Post Matriculation Studies in any general / technical or professional courses in any Govt. or Govt. recognized Private institutes, and the annual family income of the parent / guardians from all sources of those **ST/SC** students is not exceeding Rs. 2,50,000/- per annum.
- The actual family income of the parent / guardians from all sources in case of **OBC/SEBC** students should not exceed Rs. 1,00,000/- per annum and they have to secure at least 50% marks in previous examination.
- He / She should be permanent resident of Odisha.

Financial Assistance Scheme for ST students only to study in all National Level Institutes:

Eligibility:

- ST students who are continuing their Post Matriculation Studies in any National level Institute and the annual income of the parent / guardian of those ST students is not exceeding Rs. 2,50,000/- per annum.
- He / She should be permanent resident of Odisha.
- The cost of Course Fee and Maintenance Fees of these students in first instance have to be charged to Post Matric Scholarship Scheme and the excess amount exceeding the maximum limit shall be sanctioned out of Financial Assistance Scheme.
